

La Porte Police Department 2011 Annual Report Executive Summary

Department Organization and Information

Value Statement

Since its formation in 1910, the La Porte Police Department has been providing efficient, cost effective full service law enforcement to the citizens of and visitors to La Porte, Indiana in a manner that is responsive to the ever changing needs of the community.

Merit Board

The La Porte Police Department Merit Board is charged with the responsibility of hiring, promotion and discipline of all sworn officers employed by the department. The Merit Board is composed of three citizens of the City of La Porte. One member is appointed by the Mayor; one member is appointed by the City Council and one member is elected by the officers of the department.

Administration

The La Porte Police Department is headed by the Chief of Police, who was Terry Scherer in 2011. Chief Adam Klimczak took over the leadership of the department on January 1, 2012. The Chief is assisted by an Assistant Chief who is charged with many of the day to day duties of running the department. An Administrative Captain manages community policing, training and equipment for the department; is involved in serving as the department's public liaison officer with various organizations and spearheading community policing in La Porte. The Administrative Captain also assists with other duties as assigned by the Chief.

Patrol Division

The Patrol Division consists of 31 uniformed officers and supervisors and is divided into three shifts. Each shift is led by four supervisors that include a Captain, at least one Sergeant and at least one Corporal. The shift supervision is responsible for the day to day operation of each shift. Patrol Division duties consist of responding to all calls for service; enforcing all criminal and traffic laws and municipal ordinances; and conducting investigations regarding misdemeanor and lower level felony offenses.

Detective Bureau

The Detective Bureau consists of eight plainclothes officers and supervisors led by a Chief of Detectives and a Corporal. The Detective Bureau leadership is responsible for the day to day operation of the Detective Bureau such as assigning cases and coordinating and directing investigations. The Detective Bureau is charged with conducting investigations of a more serious or complex nature consisting primarily of felony crimes. Two of the detectives are assigned to the La Porte County Metro Operations Task Force.

Records Division

The Records Division is responsible for the maintenance of all records regarding case reports, traffic crash reports and criminal and traffic arrests. The Records Division personnel also process records requests, handgun permits and criminal history checks and take fingerprints for employment purposes.

Information Technology Division

The La Porte Police Department is highly computerized and very dependent on Information technology for all day to day tasks. We have one network administrator, Charles Smith, who is responsible for maintaining all of the equipment listed below:

- Maintains and oversees 12 servers.
- Maintains and oversees 44 work stations.
- Maintains and oversees 51 laptops, 44 of which are used Mobile Data Terminal laptops.
- Maintains and oversees the wireless connection to the La Porte County Complex as well as full time connectivity to three other departments and IDACS as an additional full time separate connection.
- Oversees two base station radios as well as 44 Portables and 45 Mobiles including all.
- FCC licensing and all programming.
- Maintains and oversees seven printers.
- Maintains/creates all department forms and databases.
- Maintains all stock on radio, computer and printer supplies.
- Oversee/assist 50+ users.
- CISCO Administrator/Liaison with three other agencies.
- Works with the State of Indiana on implementing and configuring all state required programs and forms.
- Recordkeeping of all software licensing and computer equipment documentation.

Activity Summary and Accomplishments

Introduction

The statistics included in both this summary and the actual data portion of the Annual Report is based on data and all data contains some inconsistencies and inaccuracies. Everything possible has been done to detect and eliminate any inconsistencies and inaccuracies in the data; however some still may exist. It should also be noted that there is some natural fluctuation from to year to be expected in the data in this report and this fluctuation cannot necessarily be tied to a particular cause. And, some categories may have wild fluctuations percentage wise; but are based on such small number that the fluctuations are not really significant.

That being said, there are some things that the reader does need to be aware of when looking at the data:

- Accident data is based on the actual traffic crashes that were investigated by the La Porte Police Department. The only exception to the Accident by Age of Driver report which includes all traffic crashes whether they were investigated or not. That is the reason that there were drivers of unknown age included in this report.
- Calls for Service and related data reflect the calls for service as they were initially dispatched or submitted to the 911 Center; not what the calls eventually ended up being.
- Offenses and related data may be thought of as incidents where a case report was actually done. Many of these incidents involved criminal offenses but there were some in which a case report was done to record the incident.
- The DUI: Taskforce Indiana, Fatality Crash Reduction Effort and Big City/Big County funding is based on the federal fiscal year and reflects money received for activities conducted between October 1, 2010 and September 30, 2011. All other grant money is figured based on calendar year 2011.

Administration

The financial constraints that the City of La Porte has been forced to operate under have continued to be extremely challenging in terms of the department being able to upgrade, or even maintain its equipment. However, there has been very little reduction in police services to the citizens of La Porte so far. The department administration has been constantly looking for ways to operate more efficiently and ways to improve the administration and processes of the police department to ensure that the best possible service is given to the citizens of the City of La Porte.

Additionally, the administration would like to list the following accomplishments for 2011:

- Purchased seven bulletproof vests. Half the cost of these vests was paid for by a Bulletproof Vest partnership grant. The La Porte Police Department is continuing to participate in the Bulletproof Vest Partnership grant in 2011.
- We will continue to participate in Big City/County, DUI: Taskforce Indiana and Fatality Crash Reduction Effort programs which brought in \$48,977.85 in additional overtime money into the department for traffic safety patrols.
- Provided security and traffic control for the Fourth of July Parade, Cruise Night, Sunflower Fair and Santa Parade in 2011.
- Continued to update Standard Operating Procedures to better document the policies and procedures of the La Porte Police Department.
- Seven new squad cars were purchased with grant money and put into service.
- Fifteen eCWS (e-citation) units were obtained from the State of Indiana Court System (JTAC) and put into service at no cost to the citizens of La Porte. These units save paper costs and increase officer efficiency due to less time being spent on traffic stops.
- Purchased new Glock duty weapons to replace the current weapons currently carried by officers which are about ten years old. The old weapons were in need of some repair parts and the department only paid about 20% of the retail cost of the new weapons in addition to trading in the old weapons.

- Purchased 19 new Tasers so that virtually everyone in the Patrol Division now has a Taser issued to them.
- Hired a new Maintenance Technician/Animal Control Officer.

Administrative Captain Julie Smith announced the following accomplishments in terms of community policing and community involvements in 2011:

- In 2011, in an effort to help prevent citizens from becoming victims of crime, and to inform the public about safety and police related activities, the La Porte Police Department issued the following press releases & Nixle advisories:
 - Cruise Night (traffic closures).
 - Sunflower Fair (traffic closures).
 - Citizen's Police Academy.
 - Fireworks use and the law.
 - Graffiti cleanup assistance program.
 - New officer hires.
- To continue with efforts in the area of crime prevention & education several more informational presentations were held this year. These presentations covered topics that are of concern to the public:
 - Panel discussion with representatives from the administration, Metro and Code Enforcement to discuss some of the problems facing the city.
 - Severe Weather Preparedness.
 - Methamphetamine Labs.
 - Domestic Violence Awareness.

Administrative Captain Julie Smith also announced the following information involving selection and training events during 2011:

- During 2011 the La Porte Police Department filled three sworn full-time police officer positions. One of these positions was made available by a COPS grant that was obtained in 2009. During 2011 both written and physical fitness testing was administered to 18 police officer applicants. The department has posted available job openings through the media via press releases and also on the Indiana Law Enforcement Academy's website.
- In 2011 officers of the La Porte Police Department received training in the following areas:
 - All officers completed their state mandatory 24 hour in-service training requirement.
 - All officers completed state mandatory training in the areas of Domestic Violence, Hazardous Materials, SIDS, Blood Borne Pathogens, Mental Illness, Human Trafficking, Theft of Valuable Metals, and Autism.
 - All officers completed mandatory training in the areas of Firearms, Physical Tactics and Emergency Vehicle Operations. All were presented by department in-house instructors. The physical tactics training was also attended by officers of the La Porte County Sheriff's Office in a mutual training agreement.
 - All officers were trained in Emergency Combat Trauma Treatment and were issued trauma packs. This type of training proved its value in

- In 2011, the La Porte Police Department maintained its training membership with the South Bend Regional Academy for the cost of \$700 annually. The Regional Academy offers approximately 15 different training courses per year allowing officers the opportunity to obtain their mandated 24 hours of in-service training. This breaks down to a cost of \$46.67 per training course, in which anywhere from one to ten officers may attend (depending on the course) for that price.
- Four officers received specialized training in drugs and street crimes investigation in Chicago.

Patrol Division

- The Patrol Division initiated or answered 24,400 Calls for Service in 2011, an increase of 8.79% over 2010.
 - Burglary in Progress calls increased 17.31% while Burglary Reports declined 10.93%.
 - Criminal Mischief calls declined 10.38% and Theft Report calls increased 10.98%.
 - Battery Report calls declined 15.29%.
 - Fridays and Saturdays are the busiest days for the La Porte Police Department with 15.42% and 15.75% of the calls for Service respectively. Sundays and Mondays are the slowest days for the department with 11.84% and 12.32% of the calls respectively.
 - The busiest hours of the day from 3:00 PM to 4:00 PM and 4:00 PM to 5:00 PM with 6.08% and 5.62% of the calls respectively. The slowest hours of the day are 4:00 AM to 5:00 AM and 5:00 AM to 6:00 AM with 1.18% and 1.21 % of the calls respectively.
 - Calls received by telephone accounted for 38.26% of the calls received followed by traffic stops at 19.91% and 911 emergency calls at 18.75% respectively.
 - Calls for Service increased by 8.79% in 2011 compared to 2010.
- Offenses reported to the La Porte Police Department in 2011 increased 4.66% in comparison to 2010.
 - Arsons of motor vehicles increased substantially.
 - Batteries increased in most categories.
 - Burglaries and attempted burglaries increased 5.52% and 83.33% respectively.
 - Operating While Intoxicated offenses increased 24.08%.
 - Mischief offenses declined, except for graffiti cases which increased 46.15%.
- Property valued at a total of \$597,023.00 was stolen and \$55,306.00 was recovered.
- At total of 1191 male adults and 366 female adults were arrested in 2011.

- A total of 207 male juveniles and 79 female juveniles were arrested in 2011.
- The total number of traffic citations written declined 18.92% in 2011 as compared to 2010.
 - Driving While Suspended citations decreased 14.29%.
 - Tobacco Violations decreased 58.33%.
 - Seat Belt citations decreased 19.75%.
 - Speeding citations decreased 39.19%.
 - Miscellaneous traffic citations increased 12.90%.
- Parking tickets written increased 7.21%.
- Traffic crashes decreased 3.08% in 2011. There were 536 property damage crashes and 108 personal injury crashes; decreases of 1.74% and 1.29% respectively. There were no fatal crashes in 2011.
 - The most dangerous day of the week was Friday with 16.88% of the crashes, while the safest was Sunday with 6.31% of the crashes.
 - The most dangerous hour of the day for crashes was 11:00 AM to 12:00 PM with 7.22% of the crashes, while the safest was 4:00 AM to 5:00 AM with 0.57% of the crashes.
 - The most dangerous intersections were State Road 2 West/Andrew Avenue, Lincolnway/Tyler Street, E Lincolnway/Boston Street and E Lincolnway/Boyd Boulevard with seven crashes each.
- The La Porte Police Department answered 870 alarms in 2011. Of these, 617 were business alarms, 176 were residential alarms, 36 were bank alarms and 41 were alarms at schools.

Detective Bureau

The Detective Bureau assigned 389 cases for investigation in 2011. Approximately 75 of these investigations lead to arrests. Of the other cases, 39 were closed because of lack of cooperation from victim, no crime committed, turned over to other agencies, or civil in nature. Approximately 116 cases were listed as pending/inactive because of lack of suspects or leads. The Detective Bureau would like to announce the following additional accomplishments for 2011:

- In terms of major case status (Part 1 Offenses reported to the FBI for inclusion in the Uniform Crime Report), there were 1425 major cases reported in 2011, an 11.84% increase over 2010. Of these, 402 were cleared by arrest or exceptional circumstances and 36 of the arrests were of juvenile suspects. The clearance rate for Part 1 Offenses was 30.73% in 2011 which is virtually identical to the 30.86% clearance rate in 2010.
- It should be noted that the Detective Bureau operated with one less detective for the majority of 2011 as compared to 2010 due to manpower issues.

Information Technology Division

Network Administrator Charles Smith announced the following accomplishments for 2011:

- Implemented the La Porte Police Department's Mobile Data Terminal (MDT) program. Among the tasks that were accomplished to implement this program were: Finished configuring the last of the MDT's for Patrol /Detective use. This

- Configured and installed new ARIES Crash Report program. Due to inability of our equipment to comply with state requirements, devised another way to comply with State. This would have cost about \$1,000 to have outsourced it.
- Finished up configuring the last of the MDT's and trained officers in their use.
- Went to multiple meetings concerning the purchase and implementation of InterAct, a new CAD, RMS and mobile software vendor. Huge project spanning the next year or so.
- Attended 120 hours of training on InterAct CAD/RMS system.
- Reloaded the operating system on 30 laptops to comply with InterAct's requirements.
- Loaded Interact mobile application on 44 laptops.
- Loaded eCWS application on 15 laptops and configured scanners and printers.
- Participated in planning the move to narrow band radio system.
- Reconfigured security cameras and systems for the police station.
- Had to assist in maintenance responsibilities due to the retirement of Ray Davis. Had to take on maintenance/ repair of all rechargeable flashlights as well as with watching boilers, furnaces etc. until this position is replaced at the first of 2011. Reworked entire heating and cooling (programming) in an attempt to get consistency and efficiency within the building.

Goals and Objectives

Administration

- To hire enough people to bring the department back to its full authorized strength and to maintain the department at that strength.
- Work toward increasing positive police contacts with the public.
- To successfully implement the La Porte Police Department's five point strategic plan which addresses the following areas.
 - Illegal narcotics trafficking in the City of La Porte.
 - The need to more effectively address the issue of gangs in the City of La Porte and surrounding area.
 - The need to make sure that warrants are served in a timely manner.
 - The higher than necessary number of traffic crashes and traffic complaints and problems in the city.
 - The need for increased code enforcement to improve the quality of life for the citizens of the City of La Porte.
- Continue to improve the operation of the police department with an eye toward increasing efficiency and effectiveness.

Training

Training goals for 2012:

- All officers meet their state mandated in-service training hours.

- All receive training in utilizing the new InterAct CAD/RMS system that will be implemented in March so that they are able to use the system to its full capabilities.
- All officers receive training regarding dealing with drug trafficking and other important issues affecting the community.
- All officers will be recertified in CPR.
- First line supervisor training for the newly promoted Sergeants.
- Taser Instructor course for whoever is designated to the Taser Instructor.
- Taser training/retraining for the entire department.
- Ground Fighting Instructor Course for the two new Defensive Tactics Instructors.
- NIMS 400 training for all Captains and above.
- Street crimes training for at least four patrol officers.
- Police ethics training.
- Supervision and leadership training.
- Instructor Development training at ILEA for officers interested in becoming instructors.
- Possibility of implementing some sort of training tracking software to track required recertification dates.

Community Policing

- Enhance the La Porte Police Department's community policing presence and participation.
- Use available technology to further community outreach efforts. The La Porte Police Department has implemented a facebook page and will look for other technology related opportunities in the future.

Information Technology

- Upgrade existing workstations and servers to provide employees with improved efficiency and effectiveness as funding becomes available.
- Implement new InterAct CAD software that will incorporate complete front to back system integration.
- Coordinate training of all personnel on the new InterAct CAD software.

Closing Comments

We are looking forward to 2012 and beyond and will constantly look for ways to better serve the citizens of the City of La Porte. We are well aware that we are facing some very serious problems in our community and it is going to citizen participation in cooperating with, communicating and supporting the police for the community to make progress in addressing these problems.

At any given point in time, there are only four to six police officers patrolling the roughly 150 miles of streets within the 12.2 square jurisdiction of the City of La Porte. So, we are dependent on help from citizens to keep us aware of problems. Any emergency situation should be reported by calling 911, while any non-emergency situations should be reported by calling (219)362-9446. Please do not assume that

because you are aware of a particular situation, that we are aware of it as well. Make that call just to ensure that we know about your concerns. The La Porte County Emergency 911 Communications Center dispatches all La Porte Police Department calls.
